<u>Great Lakes Provisional Annual Conference</u> <u>Budget Proposal and Description</u>

The proposed Conference budget for Jan. 1. 2024 to June 30, 2024, is based on these assumptions:

Income:

- The 2024 Conference connectional funding rate will be 3% starting January 1, 2024 (total connectional giving will be 4% 1% to the general church and 3% to the Great Lakes PAC).
- In aggregate, income of member churches will be similar in 2023 to their 2022 income.
- The number of churches joining the Conference will continue to increase somewhat throughout 2024.

Expenses:

- The Conference will have only two full-time employees the President Pro Tempore and an administrative assistant. An additional, part-time administrative assistant may be hired, but only if funding can be found from savings in other line items.
- The Conference will own no property, automobiles, or other significant physical assets.
- The Presiding Elders and certain Conference leaders will be reimbursed for reasonable mileage and travel expenses incurred while performing their responsibilities.
- The Conference will lease a small office space within the ConneXion Church in Kokomo, Indiana.
- Support of new church plants will be a focus, but the budget amount assumes that church planting is primarily the responsibility of existing healthy churches and not of the Conference.
- The registration fee for the 2024 Annual Conference session will be held at a maximum of \$50 with the Conference budgeting for expenses above that amount.
- The Conference will help fund the GM Church Convening General Conference to be held in San Jose, Costa Rico in September of 2024.
- The Conference will provide financial support for one or more non-US provisional annual conferences or districts.
