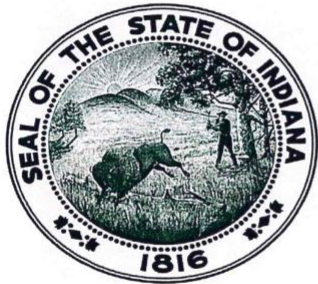

Thank you for submitting the Nonprofit Application for Sales Tax Exemption, Form NP-20A for GREAT LAKES PROVISIONAL ANNUAL CONFERENCE OF THE GLOBAL METHODIST CHURCH INC. The Indiana Department of Revenue (DOR) has approved your organization's nonprofit sales tax exemption.
